ANNUAL REPORT FOR THE YEAR 2009-2010

The Indian Institute of Advanced Study Society was established in 1965, under the Societies Registration Act of 1860. Located at the Rashtrapati Nivas, Shimla, the Institute is devoted to higher levels of research, primarily in the areas of humanities and social sciences. The academic body of the Institute consists mainly of the community of Fellows in residence as well as Visiting Professors, Visiting Scholars, Associates etc. who pursue their individual research and interact with each other, both formally and informally. Rashtrapati Nivas itself, and the natural surroundings which constitute the estate, provides an ambience conducive to living a life of the mind and exploring the different facets of the human condition.

The Institute's Memorandum of Association offers the Institute's perspective on research which is:

- (a) The areas of investigation should promote inter-disciplinary research;
- (b) The areas identified should have deep human significance.

The Memorandum of Association also spells out the areas of study, which are:

- (a) Social, political and economic philosophy;
- (b) Comparative Indian literature (including ancient, medieval, modern folk and tribal);
- (c) Comparative studies in philosophy and religion;
- (d) Education, culture, arts including performing arts and crafts;
- (e) Fundamental concepts and problems of Logic and Mathematics;
- (f) Fundamental concepts and problems of natural and life sciences;
- (g) Studies in environment both natural and social;
- (h) Indian Civilisation in the context of its Asian neighbours and the world; and
- (i) Problems of contemporary India in the context of national integration and nation-building.

The Memorandum mentions that special attention should be given to:

- (a) Theme of Indian unity in diversity;
- (b) Integrality of Indian consciousness;
- (c) Philosophy of education in the Indian perspective;
- (d) Advanced concepts in natural sciences and their philosophical implications;
- (e) Indian and Asian contribution to the synthesis of science and spirituality;
- (f) Indian and human unity;
- (g) 'Companions' to Indian Literature;
- (h) Comparative studies of the Indian epics; and
- (i) Human Environment.

I. ADMINISTRATION

During the year under report, the Indian Institute of Advanced Study Society and its Governing Body were headed by Professor Bhalchandra Mungekar, presently Member of Rajaya Sabha, former Member, Planning Commission, Government of India, who besides being a distinguished scholar, is one of India's leading agricultural economists as well as an influential thinker and reformer. The members of the Society and the Governing Body are eminent personalities, who are drawn from different walks of life. The Institute has a Finance Committee, which includes representatives from the Ministry of Human Resource Development, besides other members from the Society and Governing Body of the Institute to advise the Governing Body on financial matters.

The Institute is headed by a Director who is assisted by a Secretary and other officers. Professor Peter Ronald deSouza continued as Director in the period of report. Dr. Vijay P. Goel, Deputy Director General (Statistics), Ministry of Human Resource Development (Department of Higher Education) was given this additional charge as the Secretary of the Institute from 5th December 2008 to 18th November 2009 after which there was no Secretary at the Institute.

A. Dr. Sarvepalli Radhakrishnan Memorial Lecture

Dr. Sarvepalli Radhakrishnan Memorial Lecture is the most important event in the academic calendar of the Institute organized, if possible, every year during the birthday week of Dr. S. Radhakrishnan.

- (a) The Thirteenth Dr. Sarvepalli Radhakrishnan Memorial Lecture was organized on 16th April 2009 at the Institute. Professor B.L. Mungekar, Chairman, IIAS, and Member, Planning Commission welcomed the invitees. The Hon'ble Governor of Himachal Pradesh, Her Excellency Smt. Prabha Rau delivered the presidential address. His Excellency Shri M. Hamid Ansari, Hon'ble Vice President of India then delivered the 13th Dr. Sarvepalli Radhakrishnan Memorial Lecture entitled "The Intellectual and Society: Role and Responsibility". Professor Peter Ronald deSouza, Director, IIAS, proposed the vote of thanks.
- (b) The Fourteenth Dr. Sarvepalli Radhakrishnan Memorial Lecture was organized on 19th March 2010 at the India International Centre, New Delhi. Professor Peter Ronald deSouza, Director, IIAS, welcomed the invitees. Professor B.L. B. SEMINARS, CONFERENCES, SYMPOSIA AND ROUND TABLES

1. Seminar on "Cultural Flows across the Western Himalaya" (15-18 April 2009)

Rationale: The Seminar tried to focus on possible streams of Interdependence between various Tibetan traditions of manuscript transitions and routes along which the manuscript might have traveled. Themes that were dealt with at the Seminar include: Philology and History; Manuscript, Inscriptions and trade; Importance of Buddhism and Buddhist monuments in the history of Himachal Pradesh; Geography mapping cultural history; Importance of ancient Uddiyana for the development of visual culture across the Himalaya Buddhist philosophy in Kashmir etc. Kashmir was especially relevant to the adoption of Indian Buddhism by Tibetans as many of the Buddhist Sanskrit works were translated from the present day Srinagar. The seminar tried to underlay the structural and theoretical approaches in the themes which extended the traditional boundaries of the Discipline.

2. Seminar on "Violence in the Home" (23-25 April 2009)

Rationale: The question of violence in the home has acquired urgency in recent times. The phenomenon has acquired serious and alarming proportions with regular reports of the most macabre forms of violence being perpetrated in the precincts of the home - an arena considered to be a haven of peace, harmony, solace and love. A certain degree of tolerance to some violence in the home was inbuilt in the typical feudal-patriarchal family of the subcontinent, though this also had its safeguards; the paterfamilias was also the protector of the family. Thus, as long as the basic authority structure of the family was intact, violence per se was also contained within certain limits. However, the structure of the family varied along the axes of caste, region, and class, rural and urban residence and also kinship patterns.

A seminar on "Violence in the Home" was organized at IIAS from 23-25 April 2009. Professor Peter Ronald deSouza, Director, IIAS delivered the welcome address. Introduction to the seminar was delivered by Dr. Vasanthi Raman, Ex-Fellow, and Convener of the Seminar.

3. Workshop on "Charting the Future of Classics India" (25-26 April 2009)

Rationale: "Classical Studies" included, for the purpose of this workshop, literary or intellectual historical studies, without regard to language or region, based on texts written prior to 1800. Our aim was to help reinvigorate classical studies at a moment when they are, in the view of many, perilously endangered. The

aim was to help young scholars develop the tools for turning language knowledge into conceptually rich and historically sensitive humanistic knowledge, in the hope of enhancing the theoretical sophistication and intellectual status of classical Indian studies in the subcontinent and around the world by organising Classical Schools.

The workshop tried to reflect on some key questions such as: Have classical studies in South Asia deteriorated, and if so, what causes can be identified? What needs to be done to reverse the trend? How do we identify and then reach out to the most promising students and young faculty, the people who have a chance to make a difference in the coming generation?

A workshop on "Charting the Future of Classics India" was organized in collaboration with Columbia University at IIAS during 25-26 April 2009. Professor Sheldon Pollock, the William B. Ransford Professor of Sanskrit and Indian Studies, Columbia University and Dr. Allison Busch of Columbia University were the conveners of the workshop.

4. International Conference on "Commemorating Hind Swaraj in the 21st Century" (16-19 May 2009)

Rationale: 2009 was the centenary year of Hind Swaraj - a small book written by M.K. Gandhi in 1909 on the impacts of the British Raj. The text, which was written in a simple question-answer format, not only discussed some of the most debatable social, political and economic issues of its own time, but also produced a well-structured critique of western dominance and its cultural consequences. In fact, it became a classical commentary on colonial modernity. The Institute has had a history of a deep engagement with themes regarding the thought and legacy of Gandhi. In the seminar on "Religion and Society" held during the inauguration of the Institute in 1965, a special lecture on 'Religion of Gandhiji' was delivered by the eminent scholar Nirmal Kumar Bose. Subsequently, among other such endeavours, a major seminar on "Gandhi: Theory and Practice", was organized in 1968. A 'Multidisciplinary Team Project on Gandhian Perspectives' was launched by the Institute in 1994, following the seminar on "Gandhi and the Present Global Crisis" which discussed the broad contours of the project. The engagement of the Institute with Gandhi has been continuous through which it has published a considerable number of monographs by eminent scholars on the subject.

An International Conference on "Commemorating Hind Swaraj in the 21st Century" was organized in collaboration with Centre for Study of Developing Societies, Delhi during 16-19 May 2009 at India International Centre, New Delhi. 7. Workshop on "Comparative Electoral Ethnographies" (15-17 June 2009)

Rationale: The workshop consolidated a unique academic study in politics that has involved social anthropologists, political scientists and political philosophers. During the course of the workshop, detailed discussions were held around the main research questions covered to build a detailed ethnographic picture of the 2009 Indian elections. The results of these elections, in which the incumbent Congress led government won an unexpected majority in parliament, underscored the importance of studying the voters more carefully and the need to pay more attention to the popular perceptions of democracy and participation.

There was a high degree of synergy and collaboration between expertise in quantitative surveys and research on Indian politics and in the working of the electoral ethnographers working on the Comparative Electoral Ethnographies. An attempt was made to open a dialogue with the unique methodological innovation between quantitative and qualitative methods in studying democracy. This attempt also offered important theoretical insights that have come to be expected from the rich and diverse literature of South Asian studies, by offering, for the first time, the perceptions of the voters themselves who are usually neglected by theorists of democracy.

A workshop on "Comparative Electoral Ethnographies" was organized in collaboration with Lokniti of the Centre for the Study of Developing Societies (CSDS), New Delhi and University College, London under Summer School from 15-17 June 2009 at IIAS. 8. Summer School "Research Methodology: Analyzing Quantitative Data on Indian Politics" (16-27 June 2009)

Rationale: As research methods training remains one of the weakest aspects of university education for students of Political Science in India, a group of political scientists, both students and teachers, were selected

to improve their skills in research methods and quantitative data analysis in this two week programme. The attempt was to understand the nuances of survey research and the application of empirical methods. In addition to this an attempt was also made to discuss the imperative need for political scientists to, not only establish a clear research agenda but also to frame a suitable research question that can be tested using various appropriate research methodologies. The participants were introduced to basic statistical methods along with discussions on the reading and comprehension of survey data tables during the first three days of the workshop. After this preliminary training, during the rest of the workshop, participants were trained to analyse data using descriptive and inferential statistical techniques ranging from cross-tabulation to tests of significance and regression analysis.

A Summer School on "Research Methodology: Analyzing Quantitative Data on Indian Politics" was organized in collaboration with Lokniti, Centre for the Study of Developing Societies (CSDS), New Delhi from 16-27 June 2009 at IIAS. The Inaugural address was delivered by Professor D.L. Sheth and Professor Yogendra Yadav introduced the concept to the participants.

9. Workshop on "Narrating and Translating Women's Cultural Heritage in Chamba" (2-3 July 2009)

Rationale: The worlshop attempted to document cultural, literary and oral resources in selected areas of Bharmour and Chamba in Himachal Pradesh. It examined the broader aspects of oral history, folklore and women's narratives, and contextualised the interviews proposed for Chamba and Bharmour. It reviewed and discussed writings about Chamba literature, cultural practices, history, fiction, poetry. The narratives of older women brought a new dimension to the understanding of the region. It also dealt with feminist viewpoints on oral history, memory, migration, family and community dynamics.

10. International Conference on "50 Years of Television in India: Contemporary Issues" (14-15 July 2009)

Rationale: Television has played a crucial role in the creation and dissemination of Indian popular culture. In the early years of its history, writing on television consisted mainly of journalistic criticism or bureaucratic policy statements and appraisals. The past two decades, however, have seen the publication of a number of academic titles that have scrutinized the medium at greater depth. Today television studies is a thriving field of research located at the crossroads of a variety of academic disciplines including Anthropology, Communications, Film, Literature and Cultural Studies. Academic interest in television has coincided with major changes in the nature of the medium. Because of the shift from state-controlled to privatized broadcasting that occurred in the wake of liberalization, television is now a primary purveyor of a consumer-oriented popular culture and a crucial site for the playing out of mass-mediated politics. Given these developments, we feel that this is an opportune moment to take stock of contemporary research and to create new frames that will help us better understand television's important role in the making of contemporary modernity. The conference addressed a wide range of issues and questions: citizenship, media publics, political coverage, global and local television, television genres, broadcasting policy and television theory.

A Conference on "50 Years of Television in India: Contemporary Issues" was organized at IIAS during 14-15 July 2009. 11. Hindi Study Week on "Hindi Ki Adhunikata: Ek Punarvichar" (23-29 September 2009)

12. International Workshop on "Shakespeare and the Art of Lying" (3-7 October 2009)

Rationale: What notions of falsehood, and, axiomatically, of truth, emerge from a reading of Shakespeare's works? Does Shakespeare subscribe to the concept of absolute truth being attainable or of truth being contingent, relative? Polonius declares that he will find where truth is hid though it were hid indeed within the centre, and Hamlet in his letter to Ophelia declares, "Doubt truth to be a liar, / But never doubt I love." However, are we to take these statements at face value or enquire into their context and the nature of the person who speaks the lines? Does Shakespeare address the poststructuralist problem of language not being a mirror to reality or to truth? Is falsehood, degrees and variations of it, all we are to be content with? After all, Shakespeare himself confesses in Sonnet 110, "I have looked on truth/ Askance and strangely."

The five-day International workshop, jointly organized by the Indian Institute of Advanced Study, Shimla, and the Shakespeare Society of India, (SSI) Delhi from October 3 to 7, 2009, explored the many facets of lies, deception, truth and half-truth that feature so prominently in the Sonnets and the poems ("When my love swears that she is made of truth, I do believe her, though I know she lies") the history and Roman

plays, in the comedies, in the tragedies where falsehood has dire consequences, in the problem plays where distinctions are often blurred, and in the romances where, ostensibly, falsehood is defeated and truth is vindicated. Professor Shormishtha Panja, President, SSI, and University of Delhi was the Convener of the Workshop. Professor Bhalchandra Nemade, National Fellow welcomed the participants of the Workshop and chaired the session. Professor R.W. Desai gave the keynote address. 13. Seminar on "Celebrating 50 years of SEMINAR" (23-25 October 2009)

Rationale: In the life of a democratic nation a robust public sphere is very important. It serves as a check on the excesses of the state. It serves as a repository of new ideas and practices, of experiments in community living, forms of dissent and explorations into the future. It is a resource for forging new imaginations of the nation. Expanding the public sphere is hence very important since it results in the consolidation of democracy. A lively and robust public sphere is an investment in a better democracy.

In the last 50 years of the maturing of Indian democracy SEMINAR has, in the public sphere, occupied a unique place. It has offered itself as a platform where ideas and issues concerning the making of India, from policy concerns on environment and energy to investigations on the city, craft traditions, food and culture have been debated. In these decades SEMINAR has emerged as a public institution of international standing, one that took the symbolic stand of suspending publication during the dark period of the Emergency, one that offered its pages for developing a diverse 'Agenda for India'.

To celebrate 50 years of SEMINAR, a seminar was organized during 23-25 October 2009 at IIAS, Shimla where intellectuals from across India reflected on some aspect of SEMINAR. 14. Workshop on "UID Project and its Implications" (30-31 October 2009)

Rationale: The Unique Identity Authority of India (UIDAI) plans to issue a unique identifying number to each resident of India. The aim is to move to a system through which proving and verifying identity will be simple and reliable both for individuals and the government agencies. In this connection a number of questions and issues related to the execution, costs, risks and benefits arise.

15. Study Week on "Indian Logic and Epistemology" (2-11 November 2009)

Rationale: The structural depth in Indian philosophical systems was acquired in ancient India through dialogue among various philosophical systems. For a meaningful dialogue, however, what is most important is the language of communication. Therefore, by 1000 A.D., it was felt necessary to develop a language of precise communication. It started taking shape and by the 13th A.D. A language called Navya Nyaya language was fully developed and thereafter almost all intellectual and philosophical discourses adopted that very language of Navya Nyaya for precise communication and it continues to be used in traditional philosophical discourses even today.

A Study Week on "Indian Logic and Epistemology" was organized during 2-11 November 2009 at giving exposure to Navya Nyaya language and methodology so that scholars can know how to equip and transform themselves to have access to the original texts written in Navya Nyaya language in Sanskrit. 16. Seminar on "Politics of 'Boundary Maintenance': Inclusion-Exclusion Dynamics in North East India" (16-17 November 2009)

Rationale: The Seminar addressed the question: Does the politics of 'construction' of identities within the bounds of narrowly defined markers, such as 'belonging to a localized territory, culture and community,' constitute inevitable fallout of the larger democratic politics of representation? It sought to explore whether the needs to interrogate the notion of 'the politics of representation' and evaluate its impact on markers of identity within the larger framework of a democratic polity. The politics of representation in terms of ethno nationalism, religious fundamentalism, majoritarianism on the one hand and minority-ism on the other, poses an irresolvable dilemma for any conceptualization of democratic politics. The dilemma leads us to a conceptual maze of either privileging specific rights over the universality of right or by essentializing certain categories of identity as an inevitable outcome of history.

17. Conference on "Data to Theory Approach at LHC" (16-19 December 2009)

Rationale: The Large Hadron Collider (LHC), which has just started operating at CERN, Geneva, is expected to probe the fundamental laws of interaction of all matter at distance scales at an unprecedented level of minuteness. The experiment collides two proton beams with each other head-on and the decay products of this collision are expected to give information regarding the fundamental laws of physics. The task of extracting the footprints of some perhaps new laws of physics from the mind-boggling mass of data (on an average about a Peta Byte per year) is an extremely difficult task.

Theorists and experimentalists worldwide are therefore engaged in the pursuit of methods and concepts that ensure the best and most reliable way of arriving at theoretical scenarios from an analysis of the data at the LHC. This conference on "Data to Theory Approach at LHC" was an effort to have intensive discussion in this direction. It was organized in collaboration with The Institute of Mathematical Sciences, Chennai and Harish-Chandra Research Institute, Allahabad during 16-20 December 2009 at IIAS. Professor Biswarup Mukhopadhyaya and Professor Rahul Basu were the conveners of the Conference.

18. Seminar on "Issues in Resource Conflicts in Eastern India" (22-23 January 2010)

Rationale: Property right is an institution in the overall structure of the society and economy. It is an important class of institutional arrangements and defines the uses, which are legitimately viewed as exclusive, and who have these exclusive rights over the resources. There are four basic categories of property rights, viz, (i) open access, (ii) common property resources, (iii) private property, and (iv)state property. Access to resources comes under these types of rights. Access to resources is often contested at many levels simultaneously. Sometimes, there are attempts of people to secure rights to natural resources by having their access claims recognized as legitimate property. Struggle over resources are as much about the scope and constitution of authority as about access to resources.

The access and property rights of the poor people has been weakened and stripped at a higher rate, in the era of liberalization and privatization, particularly in the mineral rich states of Orissa, Jharkhand, and Chattisgarh in Eastern India. The process of liberalization and privatization has since 1991 opened up to the private sector (including multinationals), core sectors such as power, steel, and mines, etc., in which they were not allowed earlier. It was under the control of the state sector. In view of this, there is competition among the private sector actors in the post-liberalization era to exploit the rich natural resources including minerals to install processing and semi-processing industries particularly in eastern India

19. Winter School on "Tribes Community and Modernity" at NEHU Shillong (22 February - 4 March 2010)

Rationale: A most frequently used concept in the human sciences of anthropology, sociology, political science, and history, is the concept of a 'community'. In recent times the idea of a community has also acquired a great deal of importance in philosophical debates. It is inevitable that this variety of uses in diverse academic disciplines will influence each other - in many cases in a tacit or subterranean fashion. Apart from the more or less technical use of the concept of a 'community' in these various disciplines, it has also entered into common everyday vocabulary in phrases such as 'the international community', 'the business community', 'the student community' etc. Since very far reaching arguments in these disciplines centre round the idea of a community and that of its supposed opposite, the individual, it is of the utmost importance that we have before us as clear a map as possible of this concept.

Another related idea is that of a 'tribe'. Although this idea has a fairly well demarcated use in the discipline of anthropology, its use, like that of the concept of a community, has acquired a significantly variegated proportion in contemporary intellectual parlance. The two concepts of a tribe and a community together play a pervasive role particularly in our political debates within the framework of our democratic structure. There is also a tacit assumption that the two are most intimately connected. And yet there is very little analytic debate about either or about their inter-relationship.

In order to acquaint young scholars with these concepts a Winter School on "Tribes, Community, and Modernity" was organized from 22 February - 4 March 2010 at NEHU Shillong by the Indian Institute of Advanced Study, Shimla. Professor Sujata Miri was the Convener of the school. Professor Peter Ronald deSouza, Director, IIAS gave the Inaugural Address. 20. Seminar on "Society and Literature: Interdisciplinary Transactions" in collaboration with ICSSR, NERC Shillong, at Shillong (16-18 March 2010)

Rationale: Literature thrives on two very important functions - the representational and the hermeneutic - both of which in turn derive their essence from society and the social construction of reality. Realism, which has been a key concept in literary production, has undergone significant changes based on the variations in the perception and lived experiences of the real, of a self in its relationship to society. From a limited understanding of this term as everyday reality (bourgeoisie realism), there has been a shift to an understanding of psychological and social realism based on the self's affiliation to societal realities and ideological engagements. Therefore, the intimate connection between literature and society is genetic and epiphanic. It is genetic in the sense of society being an originary cultural and historical source of creative subjectivity. It is also characterized as an accumulation of various routes of imagination that can produce an aesthetically sublime and fictional stratum of narrative signification. It is simultaneously liminal and evanescent as society illuminates and provides representational subjects to the metaphoric and organic fabrications of language. Disciplinary transactions begin at the moment of critical dialogue between society and its subjects of representation, i.e. the text and the world.

21. Seminar on "Democracy, Identity and Group Rights" (22-23 March 2010)

Rationale: Contemporary debates in political theory and problems in politics are said to be marked by a complicated intersection between identity politics and democracy. Worldwide resurgence of claims centering on a "sense of identity" has not only provided new substance to increasing political conflicts but one that challenges and interrogates what Taylor says is the "utter facile moral psychology" of the procedural account of liberal thinking on justice. The recovery of group "identity and [its] capacity for moral agency" that purportedly was emasculated by the neutral 'atomistic' bias of liberal democracy is, therefore, being reformulated and sought to be restored through communally embedded "subject positions". It is broadly with this rationale that democratic countries in many parts of the world are engaged in devising methods through which differences of culture and claims of identity and group-differentiated rights could be reconciled institutionally with an affirmation of already existing set of individual rights.

E. INTER UNIVERSITY CENTRE

The IIAS acts as the Inter University Centre (IUC) for Social Sciences and Humanities on behalf of the University Grants Commission. The academic programmes of the IUC have three basic components: (i) the scheme of Associateship; (ii) organization of Research Seminars in different parts of the country; and (iii) holding of Study Weeks on problems of national and international interest at the Institute. The Centre invites serving teachers from the universities and colleges in the country to spend three months for three consecutive years at the Centre to: (a) complete a piece of writing that they might at the time be engaged in; (b) revise their doctoral work for publication; (c) make use of the library facilities of the Institute; and (d) interact with Fellows of the Institute and Visiting Professors and Visiting Scholars from India and abroad who come to the Institute. The Associates also take part in the seminars and conferences, both national and international, which are among the regular activities of the Institute. Apart from their own work, the Associates are also expected to participate in all the academic activities of the Institute. They are required to give at least one presentation during their stay at the Centre. It is, however, optional for Associates to submit their research paper to the Institute for publication in the Institute's journals.

(B) SEMINARS ORGANISED UNDER IUC

1. Workshop on "Treating Diversity: Traditional Medicines in Contemporary India" (18 August 2009)

Rationale: The workshop held at the Institute last year yielded a rich tapestry of insights and arguments. However, two things were required to be followed-up, which were required to enhance the quality and orientation of the publication of the proceedings. The first would be to hold a discussion on the one system that could not be adequately covered, i.e., Unani, and on the second would be to request for two new pieces on Ayurveda and the relationship of Ayurveda to Local Health Traditions, in order to fill some gaps that seem to be evident here. It is believed that these two sessions were able to cover important ground for the

book intended on this subject, which will be a unique publication. A workshop on "Treating Diversity: Traditional Medicines in Contemporary India" was organized at Delhi University, Delhi on 18 August 2009.

2. Study Week on "Philosophy in Colonial India" (9-13 Octoboer 2009)

Rationale: This study Week was an attempt to review and assess various reconstructions of 'Indian Philosophy' and the emergence of 'Modern Indian Philosophy' as exemplified in the works of Indian philosophers of the late nineteenth and early twentieth centuries in the setting of the historical conditions arising out of the two way interaction between India and Europe. Unlike the term 'Indian Philosophy', the term 'Modern Indian Philosophy' expresses an Indian response to Western philosophical traditions. More specifically, it represents the response of the English educated professional Indian philosophers of the late 19th and early 20th centuries. It not only marks the adoption and assimilation of European philosophical concepts, doctrines, and ways of thinking, but also and perhaps more significantly, marks the reinterpretation of the indigenous concepts and ways of thinking in the light of what is assimilated.

The following themes (without being exhaustive) were discussed by the speakers: (a) Orientalist and Indological reconstruction of Indian Philosophy, (b) An assessment of modern Indian philosophers' response to the western ideas and doctrines, (c) Reconstruction of traditional Vedanta, (d) Spiritualization of Indian philosophy, (e) Writing the History of Indian Philosophy, (f) Social and philosophical relevance of philosophical writings during the colonial period (g) Tradition, Creativity, and Modernity (h) Colonialism and traditional forms of knowledge.

A Study week on "Philosophy in Colonial India" was organized at IIAS during 9-13 October 2009. Professor Sharad Deshpande was convener of the Study Week. Professor Sanjay Palshikar, Fellow, IIAS, gave the Welcome Address. Opening Remarks were presented by Professor Sharad Deshpande. Concluding session was chaired by Professor Peter Ronald deSouza, Director, IIAS.

3. Autumn School on "Life and Thought of Gandhi" (1-15 December 2009)

Rationale: Over the last three decades the scholastic, intellectual, political, and social interest in Gandhiji's life and thought has acquired a new urgency and depth. Gandhiji's writings, such as "An Autobiography or the Story of My Experiments with Truth" and "Hind Swaraj" have been the subject of minute textual, philosophical, and literary studies. The theory and practice of Satyagraha, constructive work, and the institutions that Gandhiji established, have come to be studied by historians, political theorists and commentators and chroniclers of social movements. Lives of Gandhiji's associates and interlocutors like Mahadev Desai, J C Kumarrapa, Mirabehn, C F Andrews and Lanza Del Vasto have added to our understanding of Gandhiji. As a result of these studies our understanding of Gandhiana has emerged deeper, richer, and more nuanced.

An Autumn School on "Life and Thought of Gandhi" was organized at IIAS during 1-15 December 2009. Professor Tridip Suhrud was the Convener of the Autumn School. Professor S.R. Mehrotra gave the inaugural address. Professor Peter Ronald deSouza welcomed the participants and gave the Director's remarks.

The aim of the Autumn School was to acquaint the participants with this variegated intellectual tradition of thinking of, and about, Gandhiji. The School provided a non-fragmentary understanding of Gandhiji's life and thought. Quite often we have come to look at political Gandhi as quite distinct from the Gandhi of the constructive work or see Gandhiji's spiritual quest as distinct from his quest for Swaraj. The School tried to unravel the underlying relationship between seemingly disparate practices, utterances and writings.

4. Workshop on "Critical Studies in Politics" at IIAS, Shimla (4-6 March 2010)

Rationale: Our experience of teaching, doing research and guiding it, relates both to the ways in which we 'do' and teach theory, as well as the ways in which we do empirical and theoretical research. A hiatus divides the discipline along the theory/empirical question. This divide, and the very rigid ways in which 'what is theory?' is defined, seems to stand in the way of our discipline grappling with the fascinating

richness of politics in contemporary India. Many scholars who have been engaged in doing and guiding research increasingly feel that much of the difficulty in enhancing our capacities of understanding political practice, has to do with the fact of our fairly limited disciplinary.

5. Seminar on "Dayanand Bandodkar and his Ideas: Relevance for Contemporary Goa" in collaboration with Goa University, at Goa. (20-21 March 2010)

Rationale: As Goa celebrates the centenary year of its first Chief Minister, Shri Dayanand Bandodkar, it becomes an appropriate occasion to reflect on the ideas and vision that he created for Goa and the extent to which that vision has been realised by situating those ideas in contemporary Goa. As he set about the task of building a modern Goa, Bandodkar faced multiple challenges. First was the task of transforming Goa from a colonial domain to a post-colonial state with ensuing changes in policies and programmes, both economic and the social. Second, was the issue of settling the identity of the newly created state which saw the underlying tensions and apprehensions coming to the fore in the run up to the historic opinion poll. Third, was the enormous task of bringing the marginalised to the mainstream of the political and the social discourse. While steering through all the three challenging and often overlapping issues, Bandodkar led the state over nearly a decade and set about implementing policies and creating institutions which were to leave a mark on the generations to come.

A seminar on "Dayanand Bandodkar and his Ideas: Relevance for Contemporary Goa" was organized in collaboration with Department of Political Science, Goa University, Goa at Goa during 20-21 March 2010. Dr. Rahul Tripathi was the Convener of the Seminar. Dr. Tripathi welcomed the participants. Chairman's Remarks were presented by Professor Dileep Deobagkar Vice-Chancellor of Goa University. Professor Bhalchandra Nemade, National Fellow, IIAS, delivered the Keynote address. Smt. Shasikala Kakodkar, Former Chief Minister of Goa, gave the inaugural Address. Dr. Prakash Desai, Lecturer, Department of Political Science gave the vote of thanks. Valedictory Session was chaired by Professor Peter Ronald deSouza. IV. PUBLICATION

The Institute has nearly 500 publications to its credit. Through these publications, the Institute has acquired a status of its own in the academic world. The books published by Fellows include monographs submitted by the Fellows, lectures by Visiting Professors and Visiting Scholars and proceedings of the seminar held by the Institute. The Institute has adopted a multi-pronged strategy for publication - it publishes on its own and has co-publication programme with leading publishers including Oxford University Press, SAGE, Orient Blackswan, Routledge, Aryan International etc. The Institute also brings out two bi-annual journals-Studies in Humanities and Social Sciences and Summerhill IIAS Review. The journal Summerhill IIAS Review has been given a new look, which has been much appreciated by the academia. There has been some backlog with regard to SHSS, which is being cleared.

During 2009-10, the Institute sold books worth Rs. 5.50 lakh approximately. It is pertinent to mention here that the IIAS brought out second edition of the book, *The Mughal and Sikh Rulers and the Vaishnavas of Pindori* by Professor B.N. Goswamy and Professor J.S. Grewal (first published in 1969) on receiving a demand of 2000 copies of the book.

V. LIBRARY

During the year 2009-10, the Library has taken various steps to improve its services. The list of the action taken is given below:

1. Access to Electronic Resources under NLST

The Libraries worldwide are moving to add to their print base Electronic resources. The IIAS Library, being one of the best humanities and social sciences libraries in the country, has taken the initiative to build both its print and Electronic collection. The Library has acquired access to e-resources under INFLIBNET Consortium and NLIST programme of Ministry of Human Resources Development. The Fellows of the Institute can access to 5000 electronic journals and 50,000 electronic books published by major society, institute and commercial publishers under NLIST programe, National Mission of Information and Communication Technology of MHRD which is being implemented by INFLIBNET. The NLIST provides access to electronic resources to those institutes which are covered under 12 B Act of UGC. The IIAS is the only Institute in the country whose library has got the access under NLIST programe which is not covered under 12 B Act of UGC. The Fellows of the Institutes have 24x7 access to the literature of their fields covered under NLIST programe. The Fellows in all fields are taking advantage of the wealth of online information at IIAS Library. The IIAS wishes to extend this access to these electronic resources will give good value to the investments made at the IIAS.

2. Web OPAC: Access to Library Catalogue using WEB

Library has implemented web technology to access its catalogue from anywhere on the campus. Users can now access the library database from their desktop by visiting http:// 10.0.1.1:8080/ jopacv06/ html/ SearchForm. The Bibliographic records of library can be viewed and searches under title, author, publisher and place can be made from any computer on the campus which is connected to internet. This facility has enabled users to search the required document from reading rooms. Without visiting the library, they can browse the entire library collections.

3. Access to Electronic Resources

Library has enriched its collection by getting access electronic resources under INFLIBNET Consortium. Library users can access full text articles published in peer reviewed journals without any restriction of downloading. The library also has access to entire collections of full text journals published by following publishers:

4. Bar Code Project

The Library has completed the bar coding of the main collection of Library. The major sections of the library books have now got bar code labels pasted on them. It is a step towards complete modernization of IIAS library. It is proposed to initiate paperless circulation system in due course of time.

5. Stock Verification

In the process of bar coding of library collection, library has simultaneously initiated stock verification of books. The total collection of books in the library as per accession registers is 1,29,551. However in the past, many titles had not been entered in the library record. Hence, the present status of Stock verification is based on the exact number of books entered in library record. As on 31st March 2010, library identified 2293 books as missing. Efforts are being made to trace the missing books in different sections of the library. It is expected that the number of missing books will decrease once the entire library record is enetered in the libsys. The final and authentic report of Stock verification would be submitted in due course of time.

6. Information Literacy Programme

The library has introduced information literacy programme. It is a step towards bringing awareness among the user community to access electronic resources in the library. Monthly presentation is being organized for new users of the library which benefits them to get acquainted with access to e-resources.

7. Training Programme

Library organized five days training programme on Library Automation and Networking (IRTPLA) in collaboration with INFLIBNET Centre, Ahmedabad from 7th September to 11th September 2009. The programme was attended by 45 library professionals from different districts of the Himachal Pradesh. The participants were given hands on practice on SOUL software designed and developed by INFLIBNET Centre. Besides Library management software, the training modules covered lecture on Library Networking, Library Consortium, E-resources, Web page designing and RFID etc. Various resource persons from INFLIBNET and universities delivered talk on emerging issues.

8. Lecture Series

Library arranged an invited lecture for staff members of IIAS library and professionals of Himachal Pradesh Library Association by Mr. Alan Hopkinson, Head Bibliographic division of Middlesex University and UNESCO experts on Library Standards. The lecture was on Academic library systems in UK and changing role of librarians on 9th Oct, 2009 at Sidharth Vihar. Ms. Hanna Jablkowska, in-charge Institution Repository of Middlesex University also shared her experiences in building digital repository. Twenty participants from different libraries of the state attended the programme.

9. In-house Training to Library Staff

Library is using Libsys software for its in-house operation of various activities. In order to automate various sections of library, library staff were given training on various modules of library management software (Libsys). Two training programmes of one day duration were organized on use of Libsys software.

10. Re-organization of Library Collection

The library has rearranged its entire collection according to the space available in the building. The basic aim of rearrangement of collection was to find more reading space for users in library. The books on Humanities and Social Science have been kept separately at different floors of the building. Bound volumes of journals were kept at the basement of the building. The re-arrangement of these collections has helped the library enormously to find additional reading space in the library. The separate reading area has been developed where minimum twenty users can sit and study. During the course of reorganization, library has identified valuable old furniture which were unused for many years and were in a poor state. These have now been restored and adorn the library.

11. Collection Development

In order to build a rich collection in Humanities and Social Science, library has prepared the list of new titles published and covered in various book reviews, especially in Biblio, New York Review and Book Review. The list has been circulated to the Fellows of the Institute for recommendation. The library has added a total of 1561 books and 35 new periodicals.

12. Library Web page

The library has updated its website. It provides comprehensive information about library services, facilities

and membership. The initiative has also been taken to make the website more meaningful, informative and resourceful by organizing links to various free e-books, e-journals and directories in the field of Social Science and Humanities.

13. Data Consistency

One of the major issues identified in the library was data inconsistency. Consistency in the database is an integral part of database management system. The library has initiated steps to create qualitative records which will enable users to retrieve accurate information. In this regard subject headings, using Library of Congress Subject Heading for each book procured in the library is being assigned from April, 2009.

14. Computer Infrastructure

Library relies heavily on the infrastructure for delivery of its services. Information and communication technology has become absolutely critical to deliver excellent library service. Keeping in view the development of networked based services, the library has upgraded the existing computer and network infrastructure. The old Pentium III computers have been replaced with new computers. Four more Pentium IV computers have been placed for use of networked based resources. One HP server with high configuration has also been procured. In order to provide timely delivery of photocopy services to the users, one more photocopy machine has been procured in current financial year.

15. Institution Repository

The Library has taken the initiative to develop an Institution Repository at the IIAS. The repository will contain copyrighted materials published by IIAS in digital form which would be accessible worldwide. The object behind the building of the repository is to make the IIAS publication available globally. The users across the globe can now access, view, search and download the scholarly content published by the Fellows of IIAS. It is proposed to publish the monograph, working papers, annual reports, newsletter, and journals published by IIAS in the repository. The necessary open source software for building the repository has already been installed.

16. Conversion of Audio Tape to DVD

The library has taken initiative to convert all the audio CD of lectures delivered by the eminent scholars during last twenty years. After converting them to DVD format, it will be hosted on the institution repository which will enable the institute to preserve them for a longer period.

17. Inter Library Loan (ILL) through DELNET

Library is using Inter Library Loan service of DELNET. The Fellows of the Institute have made 30 ILL requests for books from different libraries. These requests were fulfilled by timely delivery of books using DELNET service.

18. Book Exhibition

The Library has organized a two day long book exhibition at IIAS from 3-4th October 2009. Twelve book

sellers and distributers participated in the exhibition. The Fellows of the Institute selected 1200 books (Approx) in various discipline.

19. Binding of Periodicals

The periodicals subscribed in the library from 2003-2008 (six years) have been sent for binding.

20. Auction of Newspapers

The old newspapers of last ten years have been auctioned. The newspapers were kept in one room which had occupied a whole lot of space. Thus there is now more space for keeping library records.

VI. DISPENSARY

The Institute has a well equipped dispensary with the post of one Resident Medical Officer, and one Pharmacist. About 3813 patients visited the dispensary during the period of 2009-2010 and 47 home visits were made by the Resident Medical Officer in emergency cases. A health camp for eye and dental check up was organized on 28th March 2010. About 92 patients were given consultation by specialist doctors.

VII. MAINTENANCE OF ESTATE AND SPECIAL REPAIR WORKS

During the year 2009-10, both the wings of the CPWD, Civil as well as Electrical, continued to attend to the day-to-day maintenance work and special repairs of the IIAS campus. The ASI has begun planning the work of restoration and preservation of the Rashtrapati Nivas Estate. The important and major works that the Institute did during this period for the improvement of the IIAS Estate are listed below:

1. Renovation and Adaptive Re-use of Swimming Pool Complex-Phase I

One of the important achievements of the Institute during year 2009-10 in the IIAS Estate was the execution of the work of renovation, for adaptive re-use, of the Swimming Pool Complex (Fire Station) portion into a Book Shop-cum-Souvenir Shop, a Coffee Shop, Ticket Counter, etc. which was inaugurated on 24th October 2010 by Smt. Nayantara Sehgal, eminent author and public intellectual. This renovation was done by the CPWD and the design was given by the Architect firm, M/s. Abha Narain Lambah & Associates. The renovated Swimming Pool Complex (Fire Station Portion) housing a Book-cum-Souvenir Shop, the Ticket Booth Counter has been appreciated by one and all. It also has modern washroom facilities for men and women.

2. Works undertaken in the Office Buildings Complex

The CPWD undertook the work of painting and polishing the interior etc. of the Public Entry Building and Guest House (Observatory House) during the first quarter. It was completed in the month of June 2009.

The Institute has also decided to develop its gardens and lawns as part of the preservation and restoration of the RP Nivas and the heritage gardens. The CPWD was assigned the work of providing a new polygreen house, two more rain water harvesting underground tanks and pop up irrigation scheme for its main lawns. These works have been undertaken by the CPWD and completed during this year.

The work relating to repair of retaining wall on road leading from Squire's Hall to Main Gate has been undertaken and completed by the CPWD during this quarter.

Another important achievement of the Estate was the cleaning of all the underground rain harvesting water tanks, which had not been done for many years.

3. Works undertaken by CPWD (Electrical)

The CPWD (Electrical) provided the underground cabling of all electrical overhead street lights wiring to save it from the monkey menace and the theft of overhead wiring during the year under review.

4. Works undertaken in the Residential Area of Fellows and Staff

The CPWD also undertook the work relating to repairs and renovation work of the Fellows' residences in various buildings of the IIAS campus like Courteen Hall Annexe, Courteen Hall, Curzon Cottage, Delvilla Main building, etc. The works relating to the doors, windows, eaves board, roofs, etc. in these buildings have been completed during the year. The work relating to repair/renovation of bathrooms and toilets in some the Fellows' residences was also taken up during the period. In some buildings this was completed while in others the work will be carried out in the next financial year. The work of PVC flooring in the Fellows' residences was also taken up during this year under report; and was completed in almost all the buildings, except one or two flats, which will be completed during the next year.

The CPWD has also undertaken the work of repair and renovation of the Delvilla Staff Quarters. The work was completed in the month of August-September 2009.

The CPWD also completed the ongoing works of the previous year in the staff quarters for the Group D employees in some of their residential blocks, namely, (a) Mali Line near Squire's Hall; (b) Out Houses near Squire's Hall; and (c) Military Barrack No. 1, where basic facilities were provided. The work was completed by April-May 2009. However, the work relating to the provision of wooden shelves was completed in the month of January-February 2010.

During this period the Institute has also been able to provide separate water tanks to the residents of 28 Family Line on its campus. The work was undertaken and completed by the CPWD.

The work relating to gutters, downpipes, etc, of A and B Block, Starry Cottage, Prospect Hill was started in February 2010.

The Roadside steps on the road and paths leading to the residential quarters were started in the month of May 2009 and were completed during the year.

5. Upgradation of Facilities in the Institute's Guest Houses

It has been decided to upgrade the facilities in the Siddharth Vihar, Guest House and other rooms of the Main Building for the Visiting Guests, Visiting Professors, Visiting Scholars, seminar participants with the provision of LCDs, tea kettles in each guest room, tea plates, biscuits etc. Also, a Welcome Letter and information on the IIAS is given to each visitor.

6. Works to be undertaken by ASI

The IIAS sanctioned the estimates submitted by ASI for repair work of Flat Roof Verandah in the Public Entry and other area of the Main Building in the last month of financial year 2008-09, i.e. March 2009. The ASI was requested to start the work at the earliest. The ASI promised to start the work in the third week of September, 2009 but the actual work started in the month of March 2010.

IX. GARDEN

The Indian Institute of Advanced Study is housed in a Heritage building (Viceregal Lodge now Rashtrapati Nivas) and has a very beautiful garden with a variety of flowers, shrubs and trees. This is perhaps one of the highest landscape gardens in the word.

The garden is dependent on rain water, which is harvested for its maintenance. Two rain water harvesting tanks with 60000 litres and 70000 litres capacity were constructed during the year 2009-10. It will reduce water insecurity at the IIAS and help in the improvement of plant growth in the nursery. Harvested rain water is being used for the maintenance of lawn and gardens as well.

For the development of garden and nursery, one Mist Chamber (40 sqmtr.) is being constructed in the Nursery. Most of the ornamented plant can only be propogated during the rainy season in the nursery. The Mist Chamber will help in propagation of rare and other ornamental plants all year around. Popup system for the irrigation of lawn in the front of main building has been installed. The Popup irrigation system saves 40% water in irrigation of the lawn.

150 trees of Devdar and other species were planted under Vanamohastava program on the Campus of the Institute. The institute's garden won the First prize and Trophy in the Shimla Flower Show organized by SAGES held in June 2009.

The garden at Observatory House (Guest House) and Siddhartha Vihar are not maintained properly due to shortage of water. It is, therefore, proposed to construct a rainwater harvesting tank at the Observatory House (Guest House) with a capacity of 50000 litres and another rain harvesting tank at Siddhartha Vihar with nearly the same capacity.

This office has audited the annual accounts of the Indian Institute of Advanced Study, Shimla for the year 2009-10 and had issued the Audit Report thereon dated 03.01.2011. During the course of audit, the following deficiencies were noticed, which were not included in the Audit Report. These are, however, being brought to your notice for taking corrective and remedial action.

(I) Fixed Asssets (Schedule-3):

Rs. 1428.15 lakh

- (i) The above includes Fixed Assets valuing Rs. 14.36 lakh, which have already been declared unserviceable but no provision towards anticipated loss of the value of these assets has been made. This has resulted in overstatement of 'Fixed Assets' and Capital Fund' as well as overstatement of 'Surplus for the year' by Rs. 14.36 lakh each.
- (ii) Instead of reducing Rs. 30.99 lakh on account of book value of written off assets from the Schedule of Fixed Assets Rs. 30.33 lakh have been reduced. This has resulted in overstatement of 'Fixed Assets' and 'Capital Fund' to the extent of Rs. 0.66 lakh each.

(II) Sundry Debtors

Debts outstanding for a period exceeding six months:

Rs. 4.82 lakh

Above includes Debts of Rs. 3.24 lakh outstanding for a period of more than three years (4 to 19 years) and are doubtful of recovery. As such to depict a correct recoverable position of Sundry Debtors, a provision for these doubtful Debts of Rs. 3.24 lakh should have been made in the accounts. Non provision for same has resulted in overstatement of 'Current Assets', 'Surplus for the year' and 'Capital Fund' by Rs. 3.24 lakh each.

(III) Loans and Advances (Schedule – 4A):

Rs. 34.86 lakh

The loans and advances include Rs. 12.20 lakh as miscellaneous advances pending for recovery since last more than three years (1972-73 to 2005-06) and are doubtful of recovery. As such to depict a correct recoverable position of loans and advances, a provision for these doubtful advances of Rs. 12.20 lakh should have been made in the 'Surplus for the year' and 'Capital fund' by Rs. 12.20 lakh each.

(IV) General

- (a) The Institute, instead of preparing the separate GPF account statements, has mixed the funds of GPF subscription and interest earned thereupon with GIA accounts. Moreover, the Institute has not followed the Government of India instructions dated 24 January 2005 regarding investment out of provident fund subscription.
- (b) The assets of Rs. 31.00 lakh were disposed of during the year, without the required prior sanction of the Government of India. This fact has not been disclosed in the 'Notes on Accounts'.
- (c) At the close of the financial year 2009-10, cheques amounting to Rs. 0.28 lakh, which were issued in favour of different parties by the Institute, had neither been cancelled nor written back for the period ranging between 35 months and 77 months. As these cheques had already become stale/invalid, these should either be revalidated or written back in the books of accounts of the Institute.
- (d) Journal for passing adjusting entries had not been maintained by the Institute.
- (e) Sundry Debtors of Rs. 4.82 lakh outstanding for a period exceeding six months years; Rs. 2.31 lakh and 11 to 19 years: Rs. 0.97 lakh). These Sundry Debtors have neither been segregated as 'Good' and 'Bad and doubtful' nor this fact disclosed in the 'Notes on Accounts'.

Separate Audit Report of the Comptroller & Auditor General of India on the Accounts of the Indian Institute of Advanced Study, Shimla for the year ended 31 March 2010

We have audited the attached Balance Sheet of the Indian Institute of Advanced Study (IIAS), Shimla as at 31 March, 2010 and the Income & Expenditure Account/Receipts & Payments Account for the year ended on that date under Section 20(1) of the Comptroller & Auditor General's (Duties, Powers & Conditions of Service) Act, 1971 read with Section 60 of the Memorandum of Association of IIAS. The audit has been entrusted for the period upto 2012-13. These financial statements are the responsibility of the Autonomous Body's management. Our responsibility is to express an opinion on these financial statements based on our audit.

- 2. This Separate Audit Report contains the comments of the Comptroller & Auditor General of India (CAG) on the accounting treatment only with regard to classification, conformity with the best accounting practices, accounting standards and disclosure norms, etc. Audit observations on financial transactions with regard to compliance with the Law, Rules & Regulations (Propriety and Regularity) and efficiency-cum-performance aspects, etc., if any, are reported through Inspection Reports/CAG's Audit Reports separately.
- 3. We have conducted our audit in accordance with auditing standards generally accepted in India. These standards require that we plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatements. An audit includes examining, on a test basis, evidences supporting the amounts and disclosure in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall presentation of financial statements. We believe that our audit provides a reasonable basis for our opinion.

4. Based on our audit, we report that:

- i. We have obtained all the information and explanations, which to the best of our knowledge and belief were necessary for the purpose of our audit;
- ii. The Balance Sheet and Income & Expenditure Account/Receipts & Payments Account dealt with by this report have been drawn up in the format prescribed by the Government of India, Ministry of Finance.
- iii. In our opinion, proper books of accounts and other relevant records have been maintained by IIAS, Shimla, as required under section 60 of the Memorandum of Association of IIAS, in so far as it appears from our examination of such books.
- iv. We further report that:

A. Balance Sheet

(a) Fixed Assets (Schedule-3) : Rs. 1428.15 lakh

The above schedule of Fixed Assets has not been prepared in accordance with Common formate of Accounts showing the gross value of Fixed assets, depreciation charged during the year, cumulative depreciation and the net value of fixed assets.

Besides, the Accounting Policy No. 3 regarding not charging of depreciation on fixed assets is also not correct

(b) Current Assets, Loans and Advances (Schedules – 4 & 4A): Rs. 420.10 lakh

Current Assets (Schedule – 4):

Rs. 385.24 lakh

Stock in Hand

Stock of IIAS Publications with Co-Publishers: Rs. 9.94 lakh

Closing stock of above publication in the ledgers worked out to Rs. 13.36 lakh instead of Rs. 9.94 lakh as shown in the accounts. This has resulted in under statement of 'Current Assets'. 'Increase/Decrease' in stock (Schedule-10) and 'Surplus for the year' to the extent of Rs. 3.42 lakh each.

(c) Current liabilities and provisions (Schedule -2):

Provisions: Rs. 296.36 lakh

The above does not include liability of Rs. 32.17 lakh on 'account of Salary, DA arrear, Fellowship grant, T.A. and LTC. etc of the Fellows and employees. This has resulted in understatement of 'Current Liabilities and Provisions' and overstatement of 'Surplus of the year' as well as 'Capital Fund' by Rs. 32.17 lakh each.

B. Grants-in Aid

Out of the total available funds of Rs. 10.52 crore (unspent balance of the previous year: Rs. 1.54 crore and grants/ receipts during the year Rs. 8.98 crore), the IIAS could utilize a sum of Rs. 9.28 crore leaving a balance of Rs. 1.24 crore as on 31 March, 2010.\

C. Management Letter

Deficiencies, which have not been included in the Audit Report, will be separately brought to the notice of the Director, IIAS, Shimla through a 'Management Letter' for taking remedial/corrective action.

- V. Subject to our observations in the preceding paragraphs, we report that the Balance Sheet and Income & Expenditure Account/Receipts & Payments Account dealt with by this report are in agreement with the books of accounts.
- VI. In our opinion and to the best of our information and according to the explanations given to us, the said financial statements read together with the Accounting Policies and Notes on Accounts, and subject to the significant matters stated above and other matters mentioned in Annexure to this Audit Report, give a true and fair view in conformity with accounting principles generally accepted in India:-
 - In so far as it relates to the Balance Sheet, of the state of affairs of the Indian Institute of Advanced Study, Shimla as at 31 March 2010; and
 - b. In so far as it relates to Income & Expenditure Account, of the 'Deficit' for the year ended on that date.

Annexure

(1) Adequacy of Internal Audit System

One Section Officer (Internal Audit) has been posted in the Institute for conducting internal audit and exercising effective checks on various activities of the Institute including its finances. However, no Internal Audit Report was submitted by the Section Officer till the date of audit (September 2010). The Institute has not prepared its own Accounting and Auditing Manuals for the guidance of its own staff for performing these functions. Besides, monthly or annual internal audit schedules are also not drawn for conducting internal audit of different activities/ wings of the Institute. Thus, the Internal Audit System in the Institute is inadequate keeping in view the size and nature of activities of the Institute and needs to be strengthened.

(2) Adequacy of Internal Control System

For internal control, different wings of the Institute are headed by Branch heads. All files by the Branch heads are submitted to the Director through the Secretary of the Institute for approval/expenditure sanction and other activities which are being carried out in the Institute. All bills and vouchers are passed by the Accounts Officer and finally expenditure sanction and approval is obtained from the director of the Institute. As such all activities of the Institute are under the over all control of the Director. Thus, keeping in view the size and nature of activities of the Institute, the Internal Control System is adequate.

(3) System of Physical verification of fixed assets

The Registers of Fixed Assets have been properly maintained. The Physical verification of Fixed Assets has not been done since 1999.

(4) Regularity in payment of statutory dues

All statutory dues were regularly paid to the concerned authorities by the Institute.

- 2. The Accounts of the Institute have been prepared on accrual basis. Provision of gratuity of Rs. 1,86,92,102.00 and leave encashment of Rs. 1,09,44,359.00 up to 31.3.2010 have been credited to capital account.
- 3. The Institute has not provided any depreciation on the fixed assets as Rule 151(4) (b) of GFR provide that the Bodies mainly financed by grants from Government will be required to maintain a register of assets in the Form (GFR 19). Further Rule 151(4) provide that as an when assets is written off, necessary note shall be kept in the Form GFR 19 by the grantee institute.
- 4. Institute received a grant-in-aid of Rs. 43.00 lakhs from the UGC during the year 2009-10. It has not been included in the main account as this was subject to audit by the firm of Chartered Accountants and accounts of this grant are required to be sent separately to the UGC duly audited by Chartered Accountants.
- 5. The Balance Sheet depicts a loss of Rs. 30,364.90 fraudulently withdrawn from the bank on forged cheques and Bank drafts during 1976. The decision of the court in the case is awaited at New Delhi.
- 6. The Closing balance as per Balance Sheet includes imprest of Rs. 10,000.00 at Institute and Rs. 20,000.00 with Chairman office at New Delhi.
- 7. Institute's Publication amounting to Rs. 23,10,676.14 and publication with Co-Publisher of Rs. 9,93,862.00 as shown in the Balance Sheet under "Fixed Assets" is based on the information submitted by PRO.

- 2. In our opinion and to the best of our information and according to explanation given to us the said accounts read with the notes contained in Schedule 2, give a true and fair view:-
